3. Name of the register	Registration register of Tecnotree Corporation's Extraordinary General Meeting to be held on July 30, 2021
4. Purpose of processing personal data / purpose of the register	<p>The right to participate in Tecnotree Corporation's Extraordinary General Meeting to be held on July 30, 2021 is determined on the basis of this register. With their own consent, the registrants provide their information to the registration register of Tecnotree Oyj's Extraordinary General Meeting, which is maintained by Euroclear Finland Oy. The information will only be used to print the list of participants, the voting list and ballot papers of the Extraordinary General Meeting and to handle any voting.</p> <p>Attached to the minutes of the Extraordinary General Meeting is a List of Participants, which is based on this register of the persons who participate in the meeting. The list of participants does not contain any information other than the names of the shareholders, the names of any agents and assistants, and the number of shares and votes. The information will not be disclosed for commercial purposes.</p>
5. Contents of the register	If a shareholder registers via the Internet, Euroclear Finland Oy will act as the technical implementer of the data collection. The communication connection from the user's browser to Euroclear Finland Oy's server is SSL encrypted. The following information can be collected through this service:

	<p>- name, personal identity number, address, telephone number, e-mail address, book-entry account number, number of shares and votes, voting information</p> <p>Other than when registering via the Internet, the registrar enters the personal data of the registrant into the system maintained by Euroclear Finland Oy, as stated in section 6. below.</p> <p>The book-entry account number is used only for identification in Euroclear Finland Oy's system and is not provided to the company.</p>
6. Regular sources of information	<p>The source of information is the registrant himself.</p> <p>When registering via the Internet, a person enters information about themselves. Based on the given personal identity number, the system compares the provided information with the company's shareholder register maintained by Euroclear Finland Oy and extracts the registrant's ownership information from the shareholder register. When issuing the authorization, the person also enters the necessary personal data for the authorized person.</p>
7. Regular data transfers and data transfers outside the EU or the European Economic Area	<p>The information in the registration register of the Extraordinary General Meeting is limited to Tecnotree Corporation's internal use, not distributed elsewhere.</p>
8. Registry security principles	<p>A. Manual material (storage and protection) The list of participants mentioned in point 4 shall be kept as an annex to the minutes of the meeting. Data of persons other than those who have registered via the Internet with the person mentioned in point 2 until the general meeting, after which they will be destroyed.</p> <p>B. Electronically stored information Retained until the registration period of the Extraordinary General Meeting and until the end of the meeting. Electronically stored data has limited access rights protected by a username and password.</p>
9. Right of inspection and exercise of the right of inspection	<p>Shareholders have the right to check the information in Tecnotree Corporation's shareholder register at Euroclear Finland Oy.</p>
